

The rules :

All participants acknowledge that they have read these rules, accept them in full and without reservation and accept the normal and frequent risks associated with cycling, such as individual or collective falls.

Article 1: The 3Virgins Bike Festival is a sporting event with 2 courses. This event does not involve timing or ranking and takes place on part of the public highway.

Article 2: Participation is open to all, licensed or not.

Article 3: Registration for the event is done online on the website visittroisvierges.lu or troisvierges.lu. The registration fees are published on the website of the event. The organisers decline all responsibility in the event of an accident during the event. For safety reasons, the organisers reserve the right to limit the number of participants in the event.

Article 4: The cyclist must wear a hard-shell helmet for the duration of the event. Each participant must present a working bicycle at the start. The organiser reserves the right to refuse the start to any participant whose bike is in too bad a condition and whose use could be considered dangerous (worn tyres or brake pads...).

Article 5: The event takes place in the Luxembourg nature park. For reasons of environmental protection and in order to preserve the cleanliness of the course and the image of cycling, it is strictly forbidden to leave waste (paper, packaging, plastic...) on the course. The organisers reserve the right to disqualify participants who voluntarily throw their waste outside the areas or bins provided for this purpose.

Article 6: The participant must make his own repairs. In case of technical impossibility to continue, he/she can call upon a car of the organizers to return to the starting point.

Article 7: Civil liability: The organiser has taken out insurance, in accordance with the legislation in force, covering his own civil liability and that of the participants involved for material or physical damage that they may accidentally cause to third parties or to each other. This contract only takes effect on the course and during the event and only for registered participants. Personal injury, personal accident insurance: the organisers have emphasised the importance of taking out personal insurance to cover any personal injury they may suffer as a result of taking part in this event. It is the responsibility of participants to insure themselves against this type of damage. Licensed participants should check with their federation to ensure that they are adequately insured against any personal injury they may suffer while participating in this type of event. If not, it is in their interest, as it is for non-licensed participants, to take out individual accident insurance with the insurance company of their choice. Material damage and liability: neither the organiser nor its insurer will cover any damage to participants' equipment, particularly in the event of a fall or theft. It is the responsibility of each participant to insure themselves against this type of risk with the insurer of their choice. Participants acknowledge that the organisers are not responsible for the surveillance of personal items in the event of theft or loss, including in the bicycle parking area. Objects, accessories or bicycles handed over to a third party (whether or not a member of the organisation) are the sole responsibility of the participant who drops them off.

Article 8: All participants in the 3Virgins Bike Festival expressly authorise the organisers and their beneficiaries or assigns, such as partners and the media, to use the still or audiovisual images in which they appear during the event, on all media, including advertising documents, throughout the world and for the longest period of time provided for by the laws, regulations or contracts. Any disagreement must be notified by letter to the organisers before the event. Address ? The organiser, his beneficiaries or his successors expressly forbid the use of the name, voice or image of the participants in any pornographic, racist or xenophobic media and more generally any use likely to harm the dignity of the participants.

Article 9: The organiser undertakes to preserve the confidentiality of personal data provided by participants in the event and to process them in accordance with the French Data Protection Act of 6 January 1978. The information collected from participants is recorded and used by the organiser to ensure the proper processing of their participation in the event and to personalise communication.

Article 10: In the event of an infringement, the participant at fault is solely responsible at his own risk, but he is also solely responsible in civil matters for accidents of which he is directly or indirectly the author or victim. The participant waives all claims against the organiser for any compensation for material or physical damage of any nature whatsoever which he/she may have caused or suffered in the course of the event.

Article 11: The courses may be modified by the organiser for safety reasons or for any other reason imposed by the competent authorities. If the event is cancelled or interrupted for reasons of force majeure or by decision of the prefecture for reasons beyond the control of the organiser, the latter shall be released from any recourse.

Article 12: The regulations may be modified by the organiser for reasons of safety or force majeure. These rules are written in French, which is the official language. They are subject to Luxembourg law. For any case not provided for above, reference shall be made to the general regulations of the FSCL in its version in force on the day of the event.
